Software License Agreement

This EULA is a binding legal agreement between you and Argonautica, Inc. dba Integrated Pro (hereinafter "Licensor") for the materials accompanying this EULA, including the accompanying computer software, associated source code, media, printed materials and any "online" or electronic documentation (hereinafter the "Software"). 1. Grant of License

3. Support Services

This EULA is a license of the Software only, and Licensor does not assume any obligation to provide maintenance, patches or fixes to the Software. Licensor further disclaims any obligation to provide support or to prepare and distribute modifications, enhancements, updates and new releases of the Software. The Licensor may, from time to time and always at its own leisure and at its own sole discretion, provide informational answers to questions about the Software via email, online documentation, phone conversations or other means; however these do not constitute support services nor do they constitute an obligation to provide further informational answers or to provide support services.

4. Replacement, Modification and/or Upgrades

If any term of this EULA is found to be unenforceable or contrary to law, it will be modified to the least extent necessary to make it enforceable, and the remaining portions of this Agreement will remain in full force and effect.

12. No Waiver

No waiver of any right under this EULA will be deemed effective unless contained in writing signed by a duly authorized representative of the party against whom

the waiver is to be asserted, and no waiver of any past or present right arising from any breach or failure to perform will be deemed to be a waiver of any future rights arising out of this EULA.

13. Entire Agreement
